

ARTICLES OF INCORPORATION OF LE JARDIN TONNIHONES OWNERS' ASSOCIATION, INC.

We, the undersigned natural persons of the age of twentyone (21) years or more, at least two of whom are citizens of the State of Texas, acting as incorporators of a corporation under the Texas Mon-Profit Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is LE JARDIN TOWNHONES OWNERS' ASSOCIATION, INC., hereinafter known as the "Corporation".

ARTICLE II

The Corporation is a non-profit corporation.

ARTICLE III

The period of its duration is perpetual.

ARTICLE IV

The purpose or purposes for which the corporation is organized are:

To administer, enforce, and otherwise implement, in any and all ways, the maintenance and operation of Le Jardin Townhomes, a condominium project located in Houston, Harris County, Texas, established pursuant to the Texas Condominium Act (Article 1301a of the Texas Revised Civil Statutes), and to exercise and perform all of the functions of a "Council of Co-Owners", as that term is defined in such Act.

To consent, approve, grant permission, and otherwise perform all such functions and do any and all things that may be permitted or required by the restrictions pertaining to said condominium project.

To promote and supervise the beautification, care, maintenance, and upkeep of said condominium project.

In general, to carry out any other activity in connection with the foregoing and to have and exercise all the powers conferred by the laws of Texas upon non-profit corporations formed under the Texas Mon-Profit Corporation Act and to do any and all other things hereinbefore set forth to the same extent as natural persons might or could do.

ARTICLE V

The street address of the initial registered office of the corporation is 6250 Westpark, Suite 222, Houston, Texas 77057 and the name of its initial registered agent at such address is James B. Gentry.

ARTICLE VI
