ARTICLES OF INCORPORATION

We, the undersigned natural persons of the age of twenty-one years or more, at feast two (2) of whom are citizens of the State of Texas, acting as incorporators of a corporation under the Texas Non-Profit Corporation Act, do hereby adopt the following Articles of Incorporation for such Corporation:

ARTICLE I

The name of the corporation is MAISON DE VILLE COUNCIL OF CO-OWNERS, INC.

ARTICLE II

The corporation is a non-profit corporation.

ARTICLE III

The period of its duration shall be perpetual.

ARTICLE IV

The purpose or purposes for which the corporation is organized are to provide for the maintenance, preservation and architectural control of the residence lots and common areas of Maison De Ville, a condominium project located in Houston, Harris County, Texas, within that certain property described as follows, to-wit:

All that certain lot, tract or parcel of land containing 6.5038 acres out of the J. R. Black Survey, Abstract No. 134, in Harris County, Texas, according to the Declaration and Bylaws thereof recorded in Volume 15, Page 1 of the Condominium Records of Harris County, Texas;

further, to promote the health, safety and welfare of the residents in the above described property and to:

- a. exercise all of the powers and privileges and to perform all of the duties and obligations of the Association as set forth in that certain Enabling Declaration for Maison De Ville, hereinafter called the "Declaration", applicable to the property and recorded in the office of the County Clerk of Harris County, Texas, in Volume 15, Page 1, of the Condominium Records of Harris County, Texas, and as the same may be amended from time to time as therein provided;
- exercise all of the powers and privileges and to perform all of the duties and obligations of a council of co-owners pursuant to and as that term is used in, the Texas Condominium Act;
- c. fix, levy, collect and enforce payment by any lawful means, all charges or assessments pursuant to the terms of the Declaration; to pay all expenses in connection therewith and all office and other expenses incident to the

conduct of the business of the Corporation, including all licenses, taxes or governmental charges levied or imposed against the property of the Corporation;

- d. acquire (by gift, purchase or otherwise) own, hold, improve, build upon, operate, maintain, convey, sell, lease, transfer, dedicate for public use or otherwise dispose of real or personal property in connection with the affairs of the Corporation;
- borrow money, and mortgage, pledge, deed in trust, or hypothecate any or all of the real or personal property of the Corporation as security for money borrowed or debts incurred, subject to any limitations imposed by the Declaration;
- f. dedicate, sell or transfer all or any part of the common areas to any public agency, authority, or utility for such purposes and subject to such conditions as may be agreed to by the members, subject to any limitations set forth in the Declaration;
- g. participate in mergers and consolidations with other nonprofit corporations organized for the purposes hereld set forth or annex additional residential property and common area, subject to any limitations set forth in the Declaration;
- h. have and exercise any and all powers, rights and privileges which a corporation organized under the Non-Profit-Corporation Law of the State of Texas may now or hereafter have or exercise.

ARTICLE V

Every person or entity who is a record owner of all or any portion of a condominium unit in Maison De Ville, including contract sellers, shall be a member of the corporation. The foregoing is not intended to include persons or entities who hold an interest merely as security for the performance of an obligation. Membership shall be appurtenant to and may not be separated from ownership of any condominium unit in Maison De Ville.

Voting shall be on a percentage basis. The percentage of the vote to which each owner is entitled is the percentage established for his undivided interest in the general common elements of Maison De Ville by the Declaration. Cumulative voting is prohibited.

ARTICLE VI

The street address of the initial registered office of the corporation is 9727 Fondren, Suite 200, Houston, Texas, 77096, and the name of its initial registered agent at such address is Suzanne W. Gasparotto.

ARTICLE VII
