THE COLLECTION POLICY of NORTHGLEN ASSOCIATION

It is hereby resolved by the Northglen Board of Directors that the following procedure be adopted in handling all accounts that reach a past due or delinquent status.

I. TCMI Functions:

- 1. Billing to owners by November 30th.
- Second billing to owners, including late fees and interest, by January 31st.
- A "balance-due" letter will be sent by the end of February.
- 4. A Certified "assessment default" notice will be sent by the end of March.
- 5. TCMI will submit accounts to the designated attorney attached to a transmittal memo that will have all supporting accounting attached.

II. Attorney Functions:

- The designated attorney will proceed with collection activity until the account reaches a prompt resolution. No correspondence will be made between the owner and TCMI during this period. However, attorney must promptly reply to homeowner calls and/or letters. All accounting will be done by the TCMI.
- Attorney shall proceed with the following steps within the time frames designated:

a.	Demand letter	10th day
b.	Title Search	10th day
c.	Lien Letter	20th day
đ.	JFC Letter	45th day
e,	Foreclosure	60th day

- 3. Filing fees must be presented to the Board in the form of an invoice for expeditious processing. When paid, TCMI will bill the appropriate charges to the owner's account.
 - 4. After an account has been resolved, the designated attorney will submit his invoice for immediate payment.
